Although the paid-up capital of the Company is at 85 Crore Equity Shares of Re. 1 each, the distinctive numbers have gone upto 93 crores due to the reason of buyback and sub-division etc. of the shares in earlier years. 2. The Company has received an intimation on 13 th May, 2026 from CB Management Services Private Limited, the Registrar and Share Transfer Agent (RTA) of the Company, communicating that it has been amalgamated with MUFG Intime India Private Limited with effect from 8 th May, 2026 pursuant to the Order passed by the Regional Director (Western Region), Ministry of Corporate Affairs, Mumbai. Consequent upon the aforesaid amalgamation becoming effective, MUFG Intime India Private Limited shall act as the Registrar and Share Transfer Agent of the Company in place of CB Management Services Private Limited.
