I, S. M. Gupta, Proprietor of M/s. S. M.  required to cast their votes electronically conveying their assent/dissent in respect of the
 Resolution on e-voting platform provided by NSDL. The remote e-voting module was disabled by
 NSDL for voting thereafter.
- 2. The shareholders holding shares as on the "cut off" date i.e. 5th November 2024 were entitled to vote on the proposed Resolution as set out in the notice of Postal Ballot of the Company.
- 3. The Company had completed the dispatch of Notice of Postal Ballot dated 4th November 2024 electronically on 18th November 2024 to all the members whose names appeared in the Register of Members/Beneficial owners as on Tuesday, 5th November 2024, being the cut-off date.
- 4. The Company had published notice in the newspapers on 19th November 2024 in Business Standard (English) and Aajkal (Bengali) for dispatch of Postal Ballot Notice electronically to members.
- 5. The votes cast by remote e-voting on the NSDL Platform were finally unblocked on 18th December 2024 at around 5.15 p.m. in the presence of two witnesses, Mrs. Enakshi Bhattacharya and Miss. Komal Pugalia who are not in the employment of the Company. They have signed below in confirmation of the votes being unblocked in their presence.
