With reference to captioned circular, SEBI has mandated **holders of physical securities** in listed Company to furnish PAN, full KYC details (Postal address with PIN, mobile number, email address, bank details, signature) and Nomination details.

In this connection, it may please be noted that the folios wherein any one of the above cited document/details are not available <u>on or after April 01, 2023</u> shall be frozen by our Registrar & Share transfer Agent (RTA). Further, such frozen securities shall be referred by the RTA or the Company to the administering authority under the Benami Transactions (Prohibitions) Act, 1988 and or Prevention of Money Laundering Act, 2002, if they continue to remain frozen as on December 31, 2025.

We find from our records that the aforesaid details with respect to the shares held by you in the Company are not complete in the database of our RTA.
